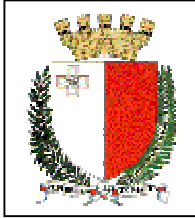

INSTRUCTIONS / INFORMATION

1. The applicant is required to get his/her Visa Application filled out with TypeWriter/Computer Printer Only (applications filled with hand are not accepted) in BLOCK letters. The Application then has to be signed by the applicant and submitted to the Consulate of Malta, New Delhi. This page should be printed at the backside of the form & signed at the bottom.

2. Along with the above, the following have to be submitted to the Consulate of Malta, New Delhi :

i) Photocopies of : Passport including relevant Visa pages, Air/Ship Ticket, Invitation Letter, Proof of Foreign Exchange Funds for the Trip (Bank Deposit Statement/Credit Card/Traveller's Cheques Issue Receipt or FTS/BTQ Issue Receipt).

ii) **Application Fees :- Rs.950/- per application** which has to be deposited at the time of submission. (This is not the Visa Fee. It is only the processing fee payable to the consulate. The Visa Fee will be charged at Malta Airport upon arrival and it is 5 Maltese Pounds (Lm) for Transit Visa, Lm 10 for Tourist Visa and double of the above amounts for Multiple Entry).

3. If the applicant's visa request is approved, he/she will be given the Visa Approval Document. With this the applicant can travel to Malta. Upon presentation of this Visa Approval Document to the Immigration Authorities at the Malta Airport, the Visa will be endorsed on the Passport.

4. Outstation applicants can print this form, fill it up and Mail / Courier it to this Consulate alongwith a Demand Draft for the above mentioned amount of Rs.950/- in favour of **Mr. O. P. Kathpalia, Hon. Consul of the Republic of Malta**, payable at Delhi. The response will be sent to the applicant by Domestic Courier, please include additional amount of Rs.50/-. Exact International Courier charges may be enquired on phone.

5. Visa Timings :- 11:00 A.M. TO 12:30 P.M. FROM MONDAY TO FRIDAY

In order to avoid inconvenience applicants are advised to strictly adhere to the above mentioned timings as they will not be entertained outside of these. Further they are advised to make their applications **well in time, ATLEAST FIFTEEN days in advance** of their intended date of departure.

Although applications will be accepted, the Consulate of Malta, New Delhi, is not responsible for the Visa clearance coming in time for the applicant's intended journey since it comes after final approval by the Principal Immigration Officer of the Government of Malta.
